Agreement and Terms

By signing below, I am authorized, and asking Wilson Oil, Inc., d.b.a. Wilcox & Flegel Oil Company (hereafter referred to as "Wilcox & Flegel" or "Seller") to open an account in the name of the Primary Applicant listed under "Bill To" on this application form (hereafter referred to as "Customer"). Customer authorizes Seller to obtain a personal (Consumer or Business) credit report(s) and to make whatever inquiries deemed necessary to establish creditworthiness, including Customer's Bank(s) or Financial Institutions as listed in this application or credit reports. Cardlock Accounts are billed as of the 15th and the last day of the month and payment is due upon receipt of invoice. Nonpayment of current charges by the consecutive billing date will constitute as a default of the contract and credit privileges will be terminated until payments are received or Seller deems appropriate. Customer represents that any of it's cards issued are to persons aware of proper cardlock use and shall practice safe handling, particularly of fire codes. Customer agrees to indemnify Seller against any misuse or negligence of the cardlock(s) by any of the persons who are in possession of Customer's cards. Customer agrees to pay finance charges at the rate of 1-1/2% monthly (18% APR) of total amount (after applying all payments and/or credits) remaining unpaid for 30 days or more. Customer agrees to pay any and all expenses incurred by Seller (including fees for legal costs and collection agency fees of every kind) to collect, defend, or assert the right of Seller, to obtain the payment of expenses and indebtedness relating to this account.

It is mutually understood and agreed that this contract shall be governed by the laws of the State of Washington, both as to interpretation and performance. The courts of the State of Washington shall have jurisdiction over all parties to this agreement and any action regarding this agreement shall be instituted only in the courts of Cowlitz or Clark or King County, Washington, at Seller's discretion. Customer agrees to notify Seller at least 30 days prior to any ownership change or transfer, or any significant change or transfer of assets, or if no notice is given, all assets of Customer shall have a lien by Seller, including those sold. Time is of the Essence of this agreement. I/we certify that all information on this application is correct and that I/we fully understand Seller's credit terms in consideration of credit extended.

Seller reserves the right to change the terms of sale and credit on this account at any time, with or without notice to you and at our sole and absolute discretion. Customer grants to Seller a Purchase Money Security Interest in all fuel inventory, and it's proceeds and receivables (PMSI), all Seller purchased/furnished equipment, and all rights of said collateral no matter where located.

ALL STATE AND FEDERAL TAXES ARE INCLUDED IN BILLING UNLESS PROPER DOCUMENTATION IS ON FILE WITH WILCOX & FLEGEL.
